

# Privacy Policy

**Harmonic Movement, LLC**

This policy explains what information I collect through this website, why I collect it, and how I handle it. Harmonic Movement, LLC is run by me, Lauren V. Coons.

## What I collect

*Information you give me.* When you contact me, sign up for my newsletter, or register for a class, I collect the information you provide. Depending on what you do, that may include:

- Your name and email address
- Your phone number, if you choose to share it
- Any message you send through the contact form
- Registration details, such as participant name, age, and emergency contact
- For group bookings, the name of your school, group, or organization and a contact person
- Anything you choose to tell me about your needs, such as an accommodation request

*Information about children.* This site is meant for adults, and I do not ask children to submit information themselves. For youth classes, I collect a child's name and age from a parent or guardian, or from the school or group booking the program, only to register them. If you believe a child has sent me information directly, contact me and I will delete it.

*Payment information.* Payments are made through Venmo or PayPal. I can see the name and amount that appear with your payment, but I do not receive your full card or bank account number. Those services handle your payment information under their own privacy policies.

*Information collected automatically.* This site is hosted on Wix and uses Wix Analytics and Google Analytics. These tools use cookies and similar technologies to collect information such as your IP address, browser and device type, the pages you visit, and how you found the site.

## How I use your information

I use your information to respond to your messages, register you for classes and keep track of who is attending, send my newsletter if you have signed up for it, and understand how people find and use this site so I can improve it.

I send my newsletter only to people who choose to subscribe. Registering for a class does not add you to my list. You can unsubscribe at any time using the link at the bottom of every email.

## Who I share it with

I do not sell your personal information. I share it only with the services I use to run this site and my practice:

- **Wix**, which hosts this site and its forms
- **Mailchimp**, which sends my newsletter to people who have subscribed
- **Google Analytics and Wix Analytics**, which help me understand how the site is used
- **Venmo or PayPal**, when you make a payment

These services have their own privacy policies and handle your information under them. I may also share information if the law requires it.

## **How I protect your information**

I take reasonable steps to protect the information you give me. This site is hosted on Wix, and payments are handled by Venmo or PayPal, which have their own security measures. Registration details are visible only to me. No website or online service can be completely secure, so I cannot guarantee absolute security, but I limit who can see your information and keep only what I need.

## **Changes to this policy**

I may update this policy from time to time. The date at the top shows when it was last changed. If I make a significant change, I will post a notice on this site and, if you are a newsletter subscriber, mention it in an email. I will say what changed and why.
